CROSSROADS FUND GRANTEEES PUSH BACK AGAINST BUDGET CUTS

Over the last several months, organizations across Chicago and the nation have anxiously watched as government officials on the state and federal level debated what funding would be cut in the name of austerity. Crossroads Fund grantees are doing more than just watching, they are taking to the streets and the halls of power to protect social services from devastating cuts.

On February 25th, 2011, a broad coalition of Chicago grassroots organizations, including current and former Crossroads Fund grantees, gathered for a teach-in about the impact of cuts to the federal Department of Housing and Urban Development. The group, which included members of the Jane Addams Senior Caucus, the Metropolitan Tenants Organization, Kenwood Oakland Community Organization, and more, then moved downtown, where they blocked rush hour traffic as part of a civil disobedience. As Liz Brake from the Jane Addams Senior Caucus explained, "The Republicans want to cut \$2.5 billion from LIHEAP, the Low Income Heating and Energy Assistance Program, but keep \$2.5 billion in drilling subsidies for the oil

industry. They plan to cut \$8.9 billion from low-income housing but keep the same amount for mortgage deductions on vacation homes."

Crossroads Fund grantee groups go beyond protesting cuts, and are proposing alternatives to provide more funding and end budget deficits. On March 19th, parents, teachers, and community members marched from the Jenner Elementary Academy of the Arts to a nearby Cadillac dealership, to call attention to the fact that Tax Increment Financing Districts siphon tax dollars from neighborhood schools, often directing funding to profitable corporations, like the luxury automobile retailer. And on April 12th, a coalition of 10 Chicago organizations, including Crossroads Fund grantees Southside Together Organized for Power and Lakeview Action Coalition, protested outside of Bank of America, to demand that the corporation and others like it pay the \$3.8 billion in taxes that they should have paid this year, but which they avoid thanks to government policies that favor corporations.

STAND UP FOR WORKER RIGHTS!

Dozens of Chicago activists traveled to Madison, Wisconsin to support weeks of protest against draconian anti-union laws proposed by the governor. Current and former Crossroads Fund grantees, including Southside Together Organized for Power, Chicago ADAPT, Jobs with Justice, Iraq Veterans Against the War, and Youth Fund Grantees Fearless Leading by the Youth (FLY) and Gen Y organized caravans of marchers to support the protests. In Chicago, thousands turned out on April 9th to mark the anniversary of Dr. Martin Luther King Jr.'s assassination, and to proclaim solidarity with workers at the "We Are One" rally.
